Yesenia agreed and said she would set a date.

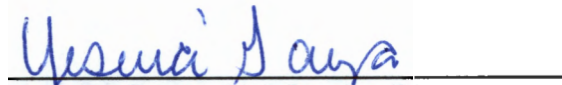
