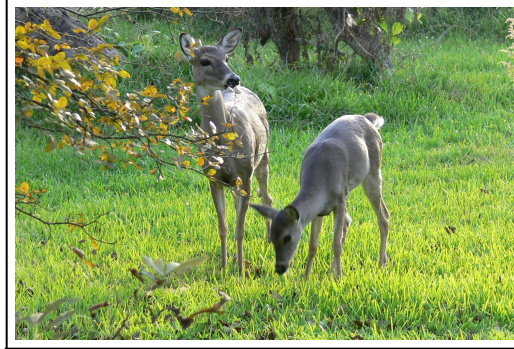


**NOTICE OF MEETING
