"Pelican Pathways" is a recommendation that was discussed and by consensus approved by City Council. The concept of the project is similar to a neighboring community that commissioned the idea to bring attention to their small businesses.

The project would be a small business-driven initiative aimed at enhancing the cultural vibrancy of our city while promoting local businesses and showcasing the beauty of our natural surroundings. It proposes the creation of a Mini-Mural Pathway Art Project, where local artists will paint pelican-themed murals on business fronts. By harnessing the power of public art, Pelican Pathways seeks to create an engaging and visually stunning experience for residents and visitors alike, fostering a sense of pride and community identity.

The proposal attached for SEDC consideration would recommend for the board to consider an amount for the budget year of a not to exceed \$5,000.00 and would allow full implementation of the program for a 50/50 grant project between the business owner and EDC.

The City would partner with the SEDC to ensure that like marketing of the pathway would be publicized and available to visitors and residents.

Mini-Mural Art Project: Pelican Pathways for Businesses

Executive Summary:

"Pelican Pathways" would be a small business-driven initiative aimed at enhancing the cultural vibrancy of our city while promoting local businesses and showcasing the beauty of our natural surroundings. This project proposes the creation of a Mini-Mural Pathway Art Project, where local artists will paint pelican-themed murals on small business fronts. By harnessing the power of public art, Pelican Pathways seeks to create an engaging and visually stunning experience for residents and visitors alike, fostering a sense of pride and community identity.

Goals:

1. Community to Business Engagement: Encourage community business participation and interaction by adding to storefronts vibrant works of art.
2. Economic Revitalization: Drive foot traffic to local businesses by creating destinations along the Mini-Mural Pathway.
3. Cultural Enrichment: Celebrate the unique identity of our city and its connection to nature through pelican-themed artwork.
4. Tourism Promotion: Attract visitors to explore our city's streets and discover the diverse range of artistic expressions.

Project Components:

1. Artist Selection and Commission: Local artists will be invited to submit proposals for small pelican-themed murals for a maximum size of 24" x 24".
2. Site Preparation and Painting: Participating businesses will collaborate with selected artists to determine mural locations and prepare storefronts for painting. Artists will then bring their designs to life and into captivating works of art.
3. Trail Mapping and Promotion: A map of the Mini-Mural Pathway will be created, highlighting the locations of each pelican mural. The map will be distributed online, and through local tourism channels to encourage residents and visitors to explore the trail and support local businesses.

4. Community Engagement Events: To further engage the community, Pelican Pathways will host events such as mural unveilings along the Mini-Mural Pathway. These events will provide opportunities for residents to connect with local business owners.

Budget Breakdown:

1. Artist Commissions: Approximately \$200.00 per painting to an approved artist (solicitation for a flat fee inclusive of materials, equipment, and site preparation)

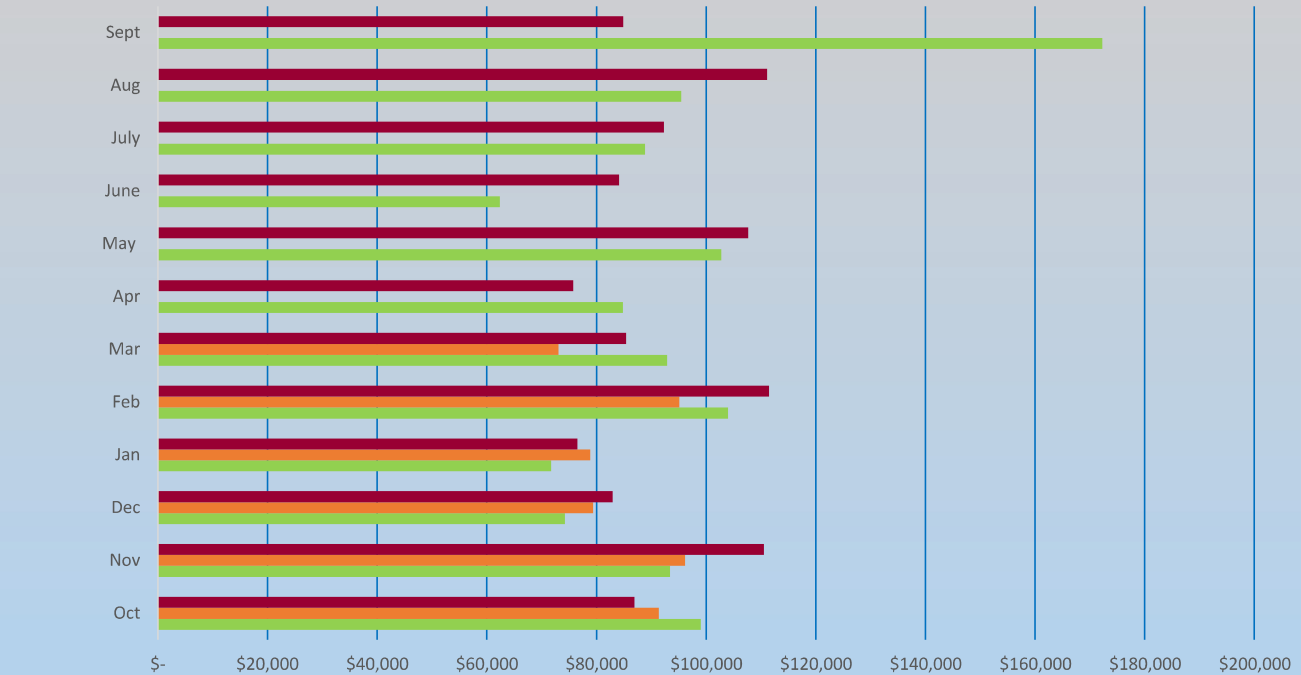
